IX. Conference Committee

Patrick Sherrington reported on the initial undertakings of WilmerHale and referenced the Formal Invitation Packages distributed as part of the Delegate Materials. Minutes

Intellectual Property and Licensing Practice Group Meeting Held November 17, 2008, Trident Hotel, Nariman Point, Mumbai, India

Jeffrey Lowe (Richards Buell Sutton) and **Takemi Hiramatsu** (Nishimura & Asahi) co-chaired this meeting.

The panel discussed IP related issues in connection with outsourcing of developments of IT assets. Following the introductory and opening remarks made by Takemi Hiramatsu, the following three speakers made their respective presentations from different perspectives:

- **Jeffrey Lowe** (Richards Buell Sutton) who made a presentation, addressing IP/IT concerns from the hiring side perspective and discussing various means of protecting IPs and interests of the hiring side in IT outsourcing.
- Mr. Rohas Nagpal (President, Asian Schools of Cyber Law) who made a presentation, especially focusing on the Information Technology Act of India as a means of coping with IP related issues involved in IT outsourcing.
- Yazdi Dandiwala (Mulla & Mulla & Craig Blunt & Caroe) who made a presentation, focusing on enforcement issues as also on the concerns of the Indian IT companies and the options under Indian law as they related to IT outsourcing.

In relation to the presentations, some interactive discussions were made with a number of questions and comments from the attendees being answered or commented by the speakers.

Finally, the session was concluded with the speakers being thanked by the co-chairs.
