The Committee Chair reported further that it would be working with the Membership Committee to further advance seeking member views as to with respect to the Membership Survey conducted by the Membership Committee,

VII. Financial - Ray Batla & Jorge Perez Taiman

Following a full report, the Board approved a motion duly made, seconded and unanimously carried. **RESOLVED** that the Board of Directors approve the 2011 Est 4th Quarter and Proposed 2012 Budget.

VIII. Membership Committee (as reported by John Shirbin) Committee Report attached as Exhibit "A".

Following review and consideration of the membership at large, the Stage 2 Report for Panama and Central America was presented by Brigard & Urrutia representative (for Carlos Urrutia) and following the Membership Committee's recommendation therein the Board voted unanimously for approval of admission of the following jurisdictions and law firms:

Panama – law firm of Arias, Fabrega & Fabrega ("ARIFA")

Central America (exclusive of Panama) – law firm of Arias & Munoz.

It is to be noted that with respect to Arias & Munoz, the offer of membership of PRAC was for the jurisdiction of Central America (exclusive of Panama) and on the basis that PRAC reserves the right to admit a firm from one of the countries of Central America (other than Costa Rica) if in the future the Board of PRAC concludes that Arias & Munoz is not covering appropriately the local market of the country and that PRAC's interest would be best served by having another member for that country.

Membership Chairman John Shirbin reported that Nishimura & Asahi formally withdrew from membership post Amsterdam and that the Membership Committee has given initial consideration to firms which would be a suitable replacement member. The Chair reported that with the 2009 resignation of Wilmer Cutler, Boston has been a vacant jurisdiction. The Chair further reminded that due to the economic constraints which are continuing to be felt in North America and in particular, the west coast, efforts to replace the Los Angeles Shared City concept by installing a single member firm was still in abeyance.

Membership Committee Chairman reported that post Amsterdam 2011 the Membership Committee conducted its tasked survey seeking member views on a number of membership related issues, including replacement members and jurisdiction expansion. Following a reporting of the overall results of the confidential survey, the Committee Chair reported its recommendation that further direction is needed and should be sought from the membership-at-large, including the views of members who had not yet responded to the survey. At the direction of PRAC Chairman, a sub-committee comprised of Policy & Planning and Membership committee members is to be installed to undertake an expanded review of member views and report on same at the Houston conference.

IX. Conference Committee

Further dates will be reviewed with a view to incorporating newly admitted member firms into the schedule with the hosting rotation of all member firms.

X. Chair Changeover (Chair, S. Sivanesan)
