IV. Chairman's Report

The Chairman commented generally on the strengths of PRAC, its attractive membership size and thus relative intimacy and the high level of participation by delegates in the conference proceedings.

(i) Sycip Salazar Hernandez & Gatmaitan - PRAC Chairman reported on the many positive comments he had received with respect to the Manila Conference and in particular the Host Firm's contributions to the business programme.

RESOLVED that the Pacific Rim Advisory Council extends **Sycip Salazar Hernandez & Gatmaitan** its deepest gratitude for planning and hosting the 60th International Conference in Manila.

(ii)Practice Groups

PRACtice Group co-chairs commented on planning for future conferences. Members were invited to contribute to future conferences by way of speaker participation and also to provide comments, feedback and suggestions by way of the Post Conference Survey.

V. Financial. The Chair reported on the ongoing deficit and the proposed expense budget of more than 9 percent and a modest 5% overall increase to annual membership fees. The Chairman noted that as part of the overall reduction, the conference allocations would be reduced by USD\$10k from USD\$78K to USD\$68K, and the Sunday Group Delegation Tour would effectively change to a paid by delegate event. This change is meant as a temporary measure and hopefully



will not be a deterrent to attendance and will be closely monitored with a view to future reconsideration. Following a full discussion, the Board approved the 2017 Budget.

VI. Policy and Planning

The Chair reported that following the Barcelona conference the ratified PRAC Membership Guidelines dated May 2016 were sent on August 10 via email to all PRAC Primary Contacts for all member firms. VII. Membership Committee – MC Chair Marcio Baptista and PRAC Chairman reported:

- (i)The Chair and Membership Committee are progressing initiatives with potential new member firms in Japan, China, Germany and California.
- (ii) **South Africa, Thailand and Boston**. The Committee is commencing due diligence and seeking recommendations and views for replacement candidate firms.
- (iii) Vietnam and Myanmar. The Committee has begun its review of these new markets with a view to expansion consideration.
