TO ALL COLOMBIA CONFERENCE DELEGATES and PRAC PRIMARY CONTACTS

Dear Friends and Colleagues:

It is just weeks since we attended PRAC's 41st International Conference in Colombia. I hope that your onward travels were pleasant.

Saturday's Bogota program opened with a warm welcome and Partner Dinner at the National Musuem where our gracious host, Brigard & Urrutia Managing Partner, Carlos Urrutia, greeted us and welcomed us to Colombia on behalf the entire BU firm. Earlier in the day, some of the Delegates and Guests along with many BU Partners and their guests, and the Host Team, attended an early arrivals tour of the Town of Usaquen and later in the day, Delegates attended a reception and tour of the Brigard & Urrutia offices. Early arrivals were also provided further opportunity to enjoy the local culture with an unforgettable evening at Andres Carne de Res.

On Sunday, the Group toured the City and the city's fine architectural heritage, taking in the Colon Theatre, San Carlos Palace, San Ignacio Church Bolivar Square, the Gold Museum, The Mint (also known as the Botero Museum) and Bogota City Hall. Along the route, some of the Group enjoyed local street food and coffee specialties which preceded a leisurely luncheon at Bogota Country Club.

Our business program began Monday morning at the Club El Nogal in the heart of the Financial and Business District in Bogota, with a Colombia Country Briefing presented by Carlos Urrutia. A panel presentation "FTA and Business Opportunities followed, with presentations by Mexico (Vicente Grau – Santamarina y Steta); Chile (Jorge Carey – Carey y Cia); Hong Kong (Tim Fletcher – Lovells); United States (Chandra Navarro-Bowman – Hogan & Hartson); and moderated by Santiago Rojas – Brigard & Urrutia, Colombia).

Following the Delegate Luncheon, Delegates and Guests departed to Cartagena for the balance of the business program.

Tuesday morning opened with Welcome and Introductions, and was followed with the Business Investment & International Trade presentation "Hot Markets- Report on Private Equity". Guest Speaker, Ken Tidwell (Carlyle Group – Washington, DC) led the panel discussion moderated by Peter Parsons (Davis Wright Tremaine – Seattle, USA); with panelists Sergio Michelsen – Brigard & Urrutia, Colombia; Manjula Chawla – Kochhar & Co., India; Tim Fletcher – Lovells, Hong Kong; and Jose Luis de Salles Freiere – Tozzini Freire Texeira e Silva.

One on One Meetings followed, with each firm meeting another for two one-half hour meetings and were followed by a panel presentation of the Projects/Infrastructure Group – "Transportation Update – Toll Roads and Mass Transit Projects, moderated by Ray Batla – Hogan & Hartson, Washington D.C., and with presentations from Jaime Martinez – Carey y Cia, Chile; Shardul Thacker – Mulla & Mulla & Craigie Blunt & Caroe – India; and Carlos Umana – Brigard & Urrutia, Colombia.

Following lunch, PRACtice Management took center stage and presented panel discussions "Succession Planning for Lawyers - Strategies for Opening Foreign Offices" and a focused look at some of the joint referral projects among our member firms. Led by Co-Chairs John Shirbin (Clayton Utz – Australia) and Jorge Perez-Taiman (Muniz Ramirez Perez-Taiman & Luna-Victoria – Peru), both topics were an open forum discussion ensured, with special additions from, among others Toronto's Richard Scott – Fraser Milner Casgrain; Patrick Sherrington (Lovells – London); Joyce Fan (Lee and Li – Taiwan); and Christophe Eck (Gide Loyrette Nouel – Paris).

A social reception followed that evening at the Cartagena home of BU Partner Sergio Michelsen prior to the group dine arounds at local restaurants.

On Wednesday morning Banking and Workouts co-chair Marcio Baptista (Tozzini Freire Teixeira e Silva, Brazil) led a focused panel discussion on "Latest Trends in Anti-Money Laundering, with presentations from Carlos Fradique (Brigard Urrutia, Colombia); Richard Johnston (WilmerHale, Boston); and Jaap Stoop (NautaDutilh, Amsterdam).

Litigation followed with co-chair Patrick Sherrington (Lovells, London) moderating a panel discussion "Resolving Disputes by Arbitration", with panelists Luis Barragan (Brigard Urrutia, Colombia); Osvaldo Marzorati (Allende Brea, Argentina); Anan Kasinather (Skrine, Malaysia) and Richard Johnston (WilmerHale, Boston).

Formal business presentations ended with Intellectual Property's session, co-chaired by Jeff Lowe (Richards Buell Sutton, Vancouver) and presentations by Juan Pablo Cadena (Brigard y Castro, Colombia); Peter Parsons (Davis Wright Tremaine, Seattle); and Jan Willem Sodderland (NautaDutilh, Amsterdam).

The Board of Directors met following lunch and the following are salient points from that meeting:

2. Policy & Planning

Batla (Hogan & Hartson, Washington, D.C.) will act as Vice-Chair; and Susan lannetta (Toronto) will continue as Director. I congratulate Patrick, Ray and Susan on their appointments and look forward to working with each of them moving forward.
