The business program began Monday morning at the Boston Harbor Hotel with an introduction from our Host Firm's Co-Managing Partner, Bill Lee, which included an insight into the issues and challenges being faced by law firms in the current market. This was followed by a Country Briefing presentation from William Burgess; two pre-assigned One on One Meetings between member firms to discuss areas of mutual interest; and then a special presentation from Ben Heineman, former Counsel of GE, entitled "Doing Business in Emerging Markets – High Performance with High Integrity".

After lunch on Monday, the entire afternoon was host to PRACtice Management's Strategic Planning for Law Firms session – which addressed "Leadership Issues for Law Firm Leaders in time of Uncertainty and Global Economic Turbulence." This featured special guest facilitator Prof. Ashish Nanda, Faculty Director and Research Director at the Program on the Legal profession at Harvard Law School and drew on the tenants of Harvard's Continuing Legal Education and Business Program course. The Board of Directors met Tuesday afternoon and the following are the salient points from that meeting:

1. Membership

Following a full report and discussion of the Membership Committee Report, the Board voted in favor of the committee's recommendation that given the current financial climate, the issue of Central America be put on hold pending further review.

2. Financial

Following a full report, the Board approved the 1st Quarter 2009 and Revised 2009 Budget.

Discussion also included the pro-active measures PRAC is taking given the current economic climate to help lessen the financial impact on its members, including an overall reduction to the 2010 budget with resulting member dues.

3. Policy & Planning

Following a full report, the Board approved clarificatory language revisions to the Statement of Policies and Objectives.

4. Nominating Committee

Following a full report, the Board voted unanimously in favor of the Committee's recommendation for future leadership positions: Chair – Ray J. Batla (Hogan & Hartson – Washington); Vice-Chair – Jorge Perez-Taiman (Muniz Ramirez Perez-Taiman & Luna-Victoria - Peru) in each case for a 2 year term commencing January 1, 2010.
