It is just weeks since we attended PRAC's 52nd International Conference in Buenos Aires. I hope that your onward travels were productive and pleasant. I thought now was the time to send you a short report to remind you of all that we achieved.

Following Saturday evening's opening reception and group dine-arounds, on Sunday we enjoyed a city tour and afternoon luncheon at Fortabat Museum. Later in the evening PRAC Delegates and Guests attended the in home Partner Dinners hosted and accompanied by several Allende & Brea partners and lawyers making for a truly exceptional evening and a standout day.

The business program began Monday morning with a Country Briefing presentation by Allende & Brea's Managing Partner, Pablo Louge, who spoke on Argentina's impact on the evolving legal landscape.

The Banking & Workouts PRACtice Group presentation followed with an excellent presentation "The Future of Bank Bailouts and Restructurings – Challenges for International Co-Operation" featuring special guest speaker Alfonso Prat-Gay followed by a panel of PRAC Delegates from cross jurisdictions including Claudette Christian, Hogan Lovells U.S., Diego Botana, Allende & Brea – Argentina; Jaap Stoop, NautaDutilh – Europe; John Shackleton, Simpson Grierson – New Zealand; Anjuli Sivaramakrishnan, Kochhar & Co. – India, and John Lorne McDougall, Fraser Milner Casgrain - Canada.

Following Monday's luncheon, the afternoon was host to PRACtice Management's session "Lawyer Retention 2012 – Great People Decisions" featuring guest speaker Claudio Fernandez Araoz, partner and member of the global executive committee in the leading executive search firm Egon Zehnder International. In preparation for this session, member firms were asked to complete an online survey specifically tailored for PRAC firms. Claudio led the session through an interactive discussion which proved to be lively and thought provoking.

Although weather forced cancellation of Monday's Accompanying Guest tour planned to Tigre Delta, our Host Team organized an equally enjoyable (and dry!) art tour to Buenos Aires' key museums.

Tuesday's session featured an extended Energy, Mining & Natural Resources PRACtice Group session "Opportunities, Challenges & Threats for Miners, Explorers and Investors Interested in South America" featuring keynote speaker Martin Dedeu, Argentine Mining Chamber (CAEM). PRAC panelists from cross jurisdictions tackled various aspects and included presentations from Juan M. Allende, Allende & Brea – Argentina; Luiz Fernando Visconti, TozziniFreire – Brazil; Luis Perez, Brigard & Urrutia – Colombia; Jorge Perez-Taiman, Muniz et al – Peru; Rafael Vergara, Carey – Chile; Ross Perrett, Clayton Utz – Australia; and James Clare, Fraser Milner Casgrain – Canada.

The Litigation/Dispute Resolution PRACtice Group session followed with presentations and a panel discussion addressing "Litigation Funding Status – Challenges & Opportunities". PRAC panelists from cross jurisdictions spoke to various aspects and included presentations from Bruce Johnson, Davis Wright Tremaine – United States; Patrick Sherrington, Hogan Lovells – United Kingdom; with pointed country contributions from David Gurfinkel, Allende & Brea – Argentina, John Shackleton, Simpson Grierson – New Zealand; Jaap Stoop, Nauta Dutilh – Europe; and John Lorne McDougall, Fraser Milner Casgrain – Canada.

The Board Meeting followed and the meeting adjourned at 5:00 pm.

Accompanying Guests enjoyed an optional tour to the world famous Teatro Colon.

Tuesday's Closing Dinner took place at Alvear Palace Hotel and which proved to be an elegant evening, topped off with an Argentine tango show.

The Board of Directors met Tuesday afternoon and the following are the salient points from that meeting:

1. Membership

- **A. Membership Committee.** The Committee has been following up on the recommendations of the Sub-Committee Report and Survey taken earlier this year in which the membership-at-large identified the top four jurisdictions for expansion, namely Japan (replacement); and new members for Germany, Spain and South Africa.
- (1) Japan. The Committee's work for the Japan jurisdiction is ongoing. Membership Chair John Shirbin asked firms to direct their comments and information on contacts at Japanese firms to the Membership Committee for purposes of seeking a member firm for Japan.
- **(2) Germany.** Vicente Grau provided an overview of the Stage 2 Report which identified a short list of preferred candidate firms for Germany. PRAC members were encouraged to direct information on contacts at identified firms to the Membership Committee for further advancement with a view to seeking admission of a member firm for Germany in the immediate months ahead.
- **(3) Spain**. The Committee's work for the Spain jurisdiction is ongoing. Jorge Perez Taiman provided an overview of the ongoing activities of the Committee for seeking a member firm for Spain.
- **(4) South Africa.** Rick Scott provided an overview of the Stage 2 report which identified a short list of preferred candidate firms for South Africa, with Werksmans Attorney identified as a top candidate. Werkmans has maintained contact with PRAC since its departure from membership in 2004 and has over the years, voiced its hope of one day returning to PRAC should membership be extended.

4. Policy & Planning.

Jorge Perez-Taiman commented on the high quality of content of the Buenos Aires business sessions and in particular the key note speakers Alfonso Prat-Gay, Martin Dedeu and Claudio Araoz. Equally, the program execution was excellent – Allende Brea's host team Pablo Louge and his team did an excellent job. The social events, in particular the Sunday tour and lunch at Fortabat Museum, the in–home Partner dinners and the Closing Dinner were warmly received.

5. Nominating Committee

As I informed during the Board meeting, I am required to appoint a Nominating Committee of not less than five member firms at least three months before the date for the election of the next Chair.

The established criteria for Nominating Committee Members, who shall not be eligible as candidates for Chair or Vice Chair, is that they shall represent geographic diversity, and shall have been associated with PRAC for a period of time sufficient to give the members reasonable knowledge of potential candidates. In keeping with this mandate, I have appointed the following Nominating Committee members:
