To All Hawaii Delegates and Primary Contacts

Dear Friends and Colleagues:

It is just days since PRAC's 63rd International Conference in Hawaii. I hope that your onward travels were pleasant. I thought now was the time to send you a short report to remind you of all that we achieved and to provide an update on our policy and membership initiatives.

On behalf of all PRAC members, I would like to extend our sincere appreciation to Michael O'Malley, Lisa Bail and the entire Goodsill team for hosting a wonderful conference. The social program started with Goodsill's warm welcome of delegates and guests at the Sheraton Waikiki at Saturday evening's opening reception, which was followed by dine arounds at local restaurants. Sunday's Delegation Luncheon and Tour to Iolani Palace was followed with a welcome reception at Goodsill's new state of the art offices.

The business program began Monday morning with a Country briefing presentation by Goodsill Managing Partner, Michael O'Malley and continued with a highly interesting topic "Security in the Pacific Region, presented by United States Pacific Command's Air Commodore Phillip Champion. The Board Meeting followed and the meeting adjourned at 4:00 pm (see notes below), followed by the Conference Committee meeting. PRAC Membership and Policy & Planning Committees met during Monday and Tuesday lunch hours.

Tuesday's Closing Dinner at Sheraton Waikiki was highlighted with a wonderfully presented cultural dance and music backdrop for a fun-filled and warm hearted evening. .

The Board of Directors met Tuesday afternoon and the following are the salient points from that meeting:

1. Financial Reporting is in line with the approved 2018 budget, with the exception of outstanding but expected annual membership fees. Membership Invoices were sent out in January.

PRAC financial transactions are currently managed by member firm Bennett Jones in trust for PRAC Services, Inc. Bennett Jones has requested PRAC Services, Inc. establish



independent banking which is currently underway.

2. Membership Committee. Member firm Rousaud (Spain) had withdrawn from membership. Committee Chair will first confer with Latin American firms to seek a potential replacement candidate.

The Chair and Membership Committee are progressing initiatives with potential new member Firms in Japan, China, Vietnam, Germany and California.

China – discussions with the Han Kun Firm are underway.

Germany – the Committee will reach out to potential candidate firm Noerr to gauge interest.

Japan –The Committee Chair is seeking recommendations for relationship/connections and views for City Yuwa as a replacement candidate firm.

United States - California and Boston. The Committee is moving forward to gauge interest with potential replacement candidates Fenwick & West, Ropes & Gray and Foley.

Vietnam – the Committee is moving forward to gauge interest with a potential candidate firm SIAM Premier.
