To All Costa Rica Delegates and PRAC Primary Contacts

Dear Friends and Colleagues:

It is just days since PRAC's 65th International Conference in Costa Rica. I hope that your onward travels were pleasant. I thought now was the time to send you a short report to remind you of all that we achieved and to provide an update on our policy and membership initiatives.

ARIAS welcomed delegates and guests to Costa Rica at Saturday evening's opening reception, which was followed by dine arounds at local restaurants. Sunday's Delegation Luncheon and Tour to El Viejo Wetlands in Palo Verde National Park exploring the Tempisque River and the panoramic views from the Hacienda sugar mill showcasing the impressive views of the Costa Rican countryside. Later in the evening, ARIAS Partners hosted a wonderful evening and dinner featuring truly "local" cuisine.
