To All Seattle Delegates and PRAC Primary Contacts

DAVIS WRIGHT TREMAINE welcomed delegates and guests at Saturday evening's opening reception at their newly occupied headquarters in downtown Seattle, which was followed by dine arounds at local restaurants. Sunday's Delegation Luncheon and Tour to Bainbridge Island and exploring the trails and foliage of Bloedel Reserve. In the evening, DWT Partners hosted wonderful n-home dinners featuring local cuisine and wines.

The business program began Monday morning with a Country briefing presentation by DWT Seattle Partner Bruce Johnson, and continued with a highly interesting keynote discussion and exchange of views "US-China Relations – What's Next?" with Governor Gary Locke, Senior Advisor and DWT Consultant, U.S. Secretary of Commerce, Ambassador to China – and Mercy Kuo, Vice President Pamir Consulting and former President and Executive Director of the Washington State China Relations Council.
