It is just days since PRAC's 67th International Conference. I hope that your onward travels were pleasant. I thought now was the time to send you a short report to remind you of all that we achieved and to provide an update on our policy and membership initiatives.

SANTAMARINA + STETA welcomed delegates and guests at Saturday evening's opening reception, which was followed by delightful dine around experiences at local restaurants. Sunday's Delegation Luncheon at San Angel Inn was a truly enjoyable and a wonderful introduction to Mexico's vibrant and rich culinary heritage. As the evening unfolded, Santamarina's Partners graciously hosted wonderful in-home dinners showcasing the latest trends in Mexican cuisine and wines, leaving no doubt that this remarkable social event remains an unforgettable experience for all attendees.

The business program kicked off on Monday morning with a presentation by Keynote Speaker, Luis Rubio - "The Economic and Political Landscape of Mexico: Opportunities and Challenges for International Legal Practice". The session provided valuable insights into the current state of the Mexican economy, its global connections, and the intricate legal frameworks that international lawyers need to navigate in order to do business in Mexico, as well as the challenges and opportunities arising from Mexico's economic and political ties with various countries in the Pacific Rim, and the implications of recent trade agreements such as the USMCA with the United States and Canada.

Monday afternoon's engaging and interactive "Managing Partners Forum –Hot Topics in Law Firm Management with Guest Moderator Leopoldo Hernandez of Kerma Partners and PRAC panelists made of up CEO's and Managing Partners provided timely and thoughtful insights into our rapidly evolving industry, particularly in a post-covid world.

The panel tackled pressing issues and emerging trends, delving into the challenges and opportunities faced by law firms in adapting to the new normal. With an emphasis on effective management strategies, the session offered valuable perspectives on navigating the changing landscape of the legal profession.

Tuesday's business sessions started with Santamarina + Steta providing an update on their firm and was followed by an insightful and interactive ESG panel discussion with guest panelist Dra. The Board Meeting followed, and the meeting adjourned at 4:00 pm. PRAC Policy & Planning and Membership Committee meetings were held during lunch hours on Monday and Tuesday (see notes below for summary).
