TO ALL PACIFIC RIM ADVISORY COUNCIL MEMBERS PRIMARY CONTACTS and NEW ZEALAND CONFERENCE DELEGATES

Dear Friends and Colleagues:

Welcome back from New Zealand and PRAC's 33rd International Conference.

For early arrivals, Saturday afternoon's experience on the America's Cup racer NZ 41 was a marvellous treat. Sailing Auckland's harbour on a windy and sun filled afternoon proved a thrilling start to the program, and a great opportunity to meet our hosts and be re-acquainted prior to the welcome reception at Simpson Grierson's offices and dine-arounds later that evening. Sunday's light rain did not seem to detract from Auckland Harbour's scenic beauty nor did it dampen our enthusiasm as activities took us by jet boat to the Waiheke Island and luncheon at Mudbrick Vineyard.

Our business programme began Monday morning at the Heritage Hotel Auckland with Welcome and Introductions, followed by a Country Briefing presented by Simpson Grierson's, Philipa Muir.

The Marketing Group followed with a focused topic "Public Relations Importance to Law Firm Marketing", with and overview by Simpson Grierson's Marketing Director, Glenda McDonald, and case studies from Ray Batla, Hogan & Hartson (Washington); Ross Perrett, Clayton Utz (Australia); and Sivi Sivanesan, Rodyk & Davidson (Singapore).

Monday afternoon's luncheon was held at the Royal New Zealand Yacht Squadron where delegates were treated to a presentation by New Zealand sports commentator Peter Montgomery, New Zealand's voice of the America's Cup. Mr. Montgomery provided interesting insights into the history of the race and its impact on New Zealand.

One on One Meetings started the afternoon session followed by Practice Management. In its continuing series "Strategic Planning for Law Firms", the results from its Knowledge Management Survey undertaken earlier in the year were reviewed, with a closer look at Simpson Grierson's knowledge management approach as presented by Simpson Grierson's Knowledge Assets Director, Mark Jeffries. The group then discussed their second topic "Planning for the New Marketplace".

Monday evening's social program "Host Firm Dinners" took groups of delegates and accompanying guests into several Simpson Grierson partner homes and where we were wonderfully received. This is always such an honour for PRAC Delegates and guests and, judging by the positive comments, Simpson Grierson's home hostings were exceptionally pleasant for everyone. During the day, accompanying guests had the option of visiting the Waitakere Ranges and West coast beaches, or visiting the Auckland Museum.

Tuesday's meetings started with a Public Seminar which was well attended by local clients and invited guests. The topic "Taking New Zealand Biotechnology to the World Marketplace - a global perspective" featured PRAC speakers: Henry Wixon, Hale and Dorr (USA); Peter Shaw, Clayton Utz (Australia); Benoit Strowel, NautaDutilh (Belgium) and Sivi Sivanesan, Rodyk & Davidson (Singapore). Delegates and invited clients, guests learned from the PRAC speakers about ways to access international biotech markets. Panel discussions were lead by Simpson Grierson's Michael Sage and Dr. Anna Jellie.

Following a luncheon break, the business programme continued with the Litigation Group, whose topic "The Golden Rules of Negotiation" proved highly successful. Michael Klug, Clayton Utz (Australia), led this innovative and interactive workshop session which we talked about well after the session ended. It is interesting to note that the self-assessment worksheets revealed a majority of PRAC delegates are collaborative negotiators. Michael also found time during the conference to present his workshop at the Simpson Grierson offices for those SG attorneys who could not attend the PRAC session.

Tuesday's afternoon business programme continued with Projects/Energy which focused on "Impact of The Kyoto Protocol", with presentations from Ray Batla, Hogan & Hartson (Washington); Chris Fonteijn, NautaDutilh (Netherlands); and Elisabeth Welson, Simpson Grierson (New Zealand).

The afternoon closed with the Intellectual Property & Licensing Group which focused on "Recent Developments in Copyright Laws" with presentations from Takemi Hiramatsu, Asahi Koma Law Offices (Japan); Henry Wixon, Hale and Dorr (USA); and Earl Gray, Simpson Grierson (New Zealand).

Tuesday evening's Gala Pacific Dinner at Heritage Auckland's Grand Tearoom closed the Auckland portion of the conference with cultural music and entertainment, including a heart pounding Maori Haka tribute. PRAC's own Takemi Hiramatsu, Asahi Koma Law Offices (Japan) also honoured us with a musical interlude, which was well received and appreciated.

Tuesday's accompanying guests spent a day in the country visiting the south countryside and New Zealand's premiere thoroughbred racehorse farm and dairy farm.

Wednesday's business meetings started with the Conference Committee, followed by the Board Meeting (See Board and Committee notes below for details). The Auckland portion of the conference closed and delegates and guests travelling on to Queenstown departed.

Queenstown

After a day on our own during which PRAC delegates and guests took in the local scenery and optional activities (such as jumping or parasailing off bridges and cliffs, mountain climbing, trekking or flying over mountain ranges and speed boating through canyon rivers) the group met Thursday early evening for a tour and dinner at the Gibbston Valley Winery.

Friday's business programme was a hosted seminar "Developing Legal Areas in the Leisure Industries - Tourism, Events, Film and Sport". Simpson Grierson Chairman Rob Fisher (Auckland) presented the Professionalism of Rugby and focused on Simpson Grierson's role in developing New Zealand Rugby Football Union ("NZRFU") as one of its top ten clients by providing a wide range of services, including player contracts, sponsorship contracts, employment and intellectual property.

Simpson Grierson's Don McKinnon detailed "Building a Sports Law Practice, and focused on the key opportunities which have arisen in the main sports areas in which they are involved.

Next, Simpson Grierson's Deborah Fox provided insight into the entertainment industry including events and sponsorship, sports, theatre, film and television (production and financing). Delegates were treated to Simpson Grierson's marketing insight and efforts which have resulted in clients such as New Line Cinema, noted for the highly successful film series "Lord of the Rings", filmed and produced in New Zealand, and for which Simpson Grierson continues to serve as primary New Zealand legal counsel.

Finally, Peter Stubbs closed the seminar with a presentation on Simpson Grierson's marketing efforts and success in New Zealand's burgeoning tourism and events industry.

All of the presentations were insightful and well received by the Delegates. Following a question and discussion period, the seminar ended and the Queenstown portion of the Conference closed.

Policy and Planning.

The Policy and Planning Committee (chaired by John Elder) reminded members to review the draft form of suggested framework for joint billing and to provide comments and or recommendations. The Policy and Planning Committee also reported on the consensus view, despite the lower number of attendees due to world events (SARS - 3 cancellations - Beijing, Malaysia and Hong Kong; war in Iraq - 2 cancellations - Mexico and Chile), that the conference was representative of a well balanced program, with excellent business and social activities intermingled, coupled with a high level of participation by the Host firm.

The Membership Chair (Patrick Sherrington) reported on the Thailand undertaking and after discussion, on unanimous approval of the Board, I am pleased to confirm that effective June 1 Tilleke & Gibbins International Ltd will join PRAC.
