TO ALL PERU CONFERENCE DELEGATES and PRAC PRIMARY CONTACTS

Dear Friends and Colleagues:

Welcome back from Peru and PRAC's 35th International Conference.

Saturday's programme opened in Lima with a visit to the Muniz offices and was a great opportunity to meet our hosts and be re-acquainted prior to the welcome reception at Huaca Huallamarca where the Inca pyramid served as a spectacular backdrop for the opening ceremony which included cultural entertainment by Limanian dancers and musicians.

Following Sunday's air transfer to the city of Cusco, Delegates and Guests enjoyed a walking tour of the City and La Catedral in the heart of the city square. In the evening, our host firm Partner Dinner at Hotel Monasterio featured guest speaker and author Peter Frost, internationally renowned for his vast experience of Cusco and the surrounding region and author of the Cusco guide provided by the Host Firm to each delegate.

Our business programme began Monday morning at the Monasterio Chapel with Welcome and Introductions and a vivid remembrance of the late Ken Slade (Hale and Dorr LLP – Boston), followed by Country Briefings presented by Muniz's Fernando Castro and new San Francisco/Palo Alto member firm Morgan Lewis & Bockius, presented by Paul Finigan.

One on One Meetings followed, with each firm meeting another for two one-half hour meetings, followed by the Marketing Session (Jorge Perez Taiman – Peru; Johns Shirbin; Australia) and focused its presentation on the survey results "Scanning the Future" in an open forum discussion format.

Delegates and Guests met for lunch and an afternoon walking tour of the City.

Tuesday's Practice Management (Jeff Barnes – Canada; Warren Gorrell – Washington DC) presented their continuing series Strategic Planning for Law firms, focusing on the results of a recent Partnership Admission Survey and an open forum discussion followed.

Following lunch, Projects/Energy (Jose Emilio Nunes Pinto – Brazil; Ray Batla – Washington DC) presented "Structuring & Financing Natural Gas Pipelines and LNG Projects" with presentations by Jorge Perez Taiman (Peru) on the Camisea Natural Gas Project; Ray Batla (Washington) on the North American LNG Projects; and John Shirbin (Australia) on the Australian LNG Projects. An open forum discussion followed.

Lateral Sessions followed. Litigation (Patrick Sherrington – London; Ross Perrett – Australia) presented "Litigator's Guide to Managing Electronic Information Overload" with presentations by Paul Finigan (San Francisco); David Gurfinkel (Argentina); and John King (Thailand). An open forum discussion followed.

Business Investment & Trade (Peter Parsons – Seattle, Washington) presented "Disclosure of Greed and Corruption in the Boardroom", with presentations by Albert Forsyth (Peru); Jan Willem Sodderland (Amsterdam); Xuhua Huang (Beijing) and Peter Parsons (Seattle).

During the day Accompanying Guests visited Chinceros, Ollanttaytambo, Tunupa Valley and Pablo Seminario.

Tuesday evening's reception at Qoriancha Inca Temple was exceptional. Delegates and guests, all wearing the customary locally made "poncho", were treated to a special welcome by a local choir of school children who charmed their way into our hearts with their smiles and songs.

Wednesday's business programme consisted of the Board Meeting (see notes below). Following lunch, Delegates and Guests visited the Inca Ruins at Tambo Machay, Puca Pucara, Qengo and Sascayhuaman.

The Closing Dinner took place later that evening amidst the stunning backdrop of the Pre-Columbian Art Museum. Local dancers welcomed Delegates and Guests in the Monasterio Square followed by dinner at the Museum. During the evening, we were treated to the sounds of local Cusco group, Arco Iris who brought Delegates and Guests to their feet, dancing and singing. A marvelous ending to the Cusco programme and a fitting tribute to the Host Firm who arranged for us to share this very special City with us, if only for a few days.

Thursday's optional programme transferred by early morning train to Machu Picchu and the town of Aquas Calientes, and a tour of the Inca Ruins. Several Delegates and Guests showed their fitness in the heights of the Inca Trail and Huayna Picchu.

Ending the conference was Friday's business presentation by the Environmental and Native Rights group (Vince Piekarski – Hawaii; Denis McNamara – New Zealand); with a presentation by Armando Arrieta ((Muniz) who provided an overview of the Peruvian environmental and native communities' legislation and enforcing agencies and impact on specific cases of problems in the mining and hydrocarbon industries. An open forum discussion followed.

Delegates and Guests departed later in the day for return to Cusco and departed Saturday for Lima and international flights.

Board Meeting Notes

The Board Meeting held on Wednesday morning attended to the business aspects. Draft minutes will be available shortly at the PRAC web site.

Policy and Planning - Conference report

The Policy and Planning Committee Chairman (Jose Emilio Nunes Pinto – Tozzini Freire Teixeira e Silva, Brazil) reported on the consensus view, that the Peru conference was representative of an extremely well planned and executed, highly ambitious programme, with several cities, venues and modes of transport involved. It was a well balanced program, with excellent business and social activities intermingled, coupled with a high level of participation by the membership and accompanying guests. Other items as reported by the Policy and Planning Committee will be reported in the Board Minutes.

Membership

The Membership Chair man (S. Sivanesan – Rodyk & Davidson, Singapore) reported on the following:

- **1. Spain.** It was decided to put the consideration for a member from Spain on hold. It can be revived at the next conference if need be.
- **2. South Africa.** Members felt the need for a replacement member for South Africa. The membership committee will consider this a stage 2 issue and consider suitable candidates.
- **3. Los Angeles.** The majority consensus showed that a strong LA firm should be considered for the LA membership. Whilst having LA an "open city" was considered by some members, this was not the preferred view of most members. It was also not in PRAC's interest to consider or invite a 2nd or 3rd tier LA firm. Morgan Lewis had offered to provide its LA office as a candidate. In view of the sensitivities of the US members, it was decided to not make any decision at least for the next 6 months (until the Delhi

conference), so that the Committee and members can consider more options, potential candidates etc. Members were urged to provide feedback or views to the Membership committee.

Obviously due to time constraints, not all groups will be meeting in India so please note availability is limited.
