# TO ALL HAWAII CONFERENCE DELEGATES and PRAC PRIMARY CONTACTS

Dear Friends and Colleagues:

Welcome back from Hawaii and PRAC's 37th International Conference.

Saturday's programme opened in Honolulu with a reception at the Royal Hawaiian where our Host Firm and special guest Oahu's Honorable Mayor Mufi Hanneman warmly welcomed us. Earlier in the day, some of the Delegates and Guests attended early arrivals tours with a climb of Diamondhead and Iolani Palace. Dine arounds at local restaurants provided further opportunity for our Host Firm, Delegates, and Guests to be reacquainted and enjoy local cuisine.

Sunday's group tour of Oahu's traditional scenic spots end with a relaxed luncheon in early afternoon. Later that evening, our Host Firm welcomed us at the Bishop Museum for their Partner Dinner. The Museum is home to an extensive collection of Hawaiian artifacts and royal family heirlooms and a wonderful setting for dinner. Included was a program "Ola Na Mo'olelo, providing an oral history brought to life by the use of the Museum's artifacts and local Hawaiian entertainment.

Our business programme began Monday morning at the Royal Hawaiian with Welcome and Introductions, followed by Country Briefings presented by our Host Firm.

One on One Meetings followed, with each firm meeting another for two one-half hour meetings, followed by Marketing Practice Group Co-Chairs John Shirbin – Australia and Jorge Perez-Taiman - Peru presented results of our member *Secondment Survey* taken earlier.

Following the Policy & Planning Committee's Working Lunch on PRAC Fee Assessments, Environment & Native Rights Practice Group presented the *Mauna Kea Telescope Case Study*, featuring special guest speaker Rolf-Peter Kudritzki, Ph.D, Director Institute for Astronomy, University of Hawaii, and Goodsill's Lisa Woods Munger.

Monday's business program closed with the Tax Practice Group Co-Chairs leading discussions on *"Tax Incentives to Encourage New Industries"* with presentations by Chris Warner – Netherlands; Marcio Baptista – Brazil; Russel Kaupu and Ric Galindez – USA.

Earlier in the day, accompanying quests had enjoyed a catamaran cruise off of Waikiki Beach.

Tuesday's business meetings began following a tour of the Goodsill offices in downtown Honolulu. PRACtice Management held panel discussions on two issues, *Conflicts* and *Requests for Proposals*. Results of a member survey undertaken earlier in the year were used in the discussions. Panel 1 Request for Proposal discussions with Ray Batla – Washington; Joyce Fan – Taiwan and Osvaldo Marzorati – Argentina was led by Jeff Barnes. Paul Finigan – San Francisco; Brad Vann – Melbourne and Ray Iwamoto, Honolulu, were led by Joe Weinstein – Seattle in the Conflict discussions. Fueled by the topics and panel discussions, PRACtice Management continues to be particularly interactive with audience participation.

Following the Delegate Luncheon at the Plaza Club, Delegates returned to the Royal Hawaiian for the afternoon business program, Litigation (Co-Chairs Patrick Sherrington – London and Ross Perrett – Australia) which focused on "Insurance Post 9/11" with presentations by Alan Fujimoto – Hawaii; Shardul Thacker – Mumbai; and Paul Finigan – San Francisco.. The Litigation Group confirmed its launching of a project for the collection of data to create a matrix as to the enforceability of foreign awards and judgments in each of the PRAC jurisdictions.

Banking & Workouts ended Tuesday's business program with a focus presentation on "Lien Creation and Priority with presentations by Sherry Lin – Taiwan; Walter Davison – Hawaii.

During the day, accompanying guests visited the Contemporary Museum and Gardens.

Tuesday evening's closing dinner was a Luau held on the ocean lawn of the Royal Hawaiian Hotel and featured local Hawaiian cultural entertainment. A great fun time under the stars - even Elvis looked to be having a good time!

Following Wednesday's Board Meeting, the optional programme transferred delegates and guests to the Big Island of Hawaii. On Thursday, attendees visited the Mauna Kea Observatory and telescopes.
