#### **TOUR AND INFORMATION GUIDE**

#### THE PHILIPPINES

The Philippines is an archipelago composed of 7,107 islands. It is rich in natural resources, world famous beaches and tropical rainforest. It has a total land area of about 300,000 square kilometers (116,000 square miles). It is divided into 3 island groups namely: Luzon, Visayas and Mindanao. Manila, the capital is located in Luzon.

#### Climate

The climate is hot, humid and tropical. Average temperatures 78F/25C to 90F/32C, humidity: 77%. Periods of rain can happen anytime.

#### **Time Zone**

There is only one time zone for the entire country, which is 120 degrees East Meridian Time and eight hours in advance of the Greenwich Mean Time (GMT +0800H).

#### Language

Filipino is the national language. English is the business language and spoken widely. Approximately 111 languages and dialects are spoken in the country.

#### **Electricity and Water**

The Philippines uses 220V electric power. Tap water is potable, however, it is not recommended for travelers. Most establishments provide bottled water.

#### **Currency and Credit Cards**

The country's unit of currency is the Philippine Peso (PHP). The exchange rate as of June 1 2016 is approximately 1.00 USD=45.8254 PHP 1 PHP=0.022 USD. Foreign currencies can be exchanged at the airport, designated banks, malls, hotels resorts and ATMS. Major credit cards are accepted throughout the Philippines with the exception of markets or small shop vendors who deal mostly in PHP cash transactions. Avoid money changers dealing on the street. Traveler's checks may be cashed at foreign-exchange banks, some tourist oriented business establishments and international hotels.

#### **Banking Hours**

Most banks are open from Monday to Friday from 9:00 am to 3:00 pm. Automated Teller machines (ATMs) are available 24 hours within Metro Manila.

#### **Airport Fees**

All passengers departing from the NAIA (Ninoy Aquino International Airport) are expected to pay the Airport Terminal Fee of PHP750.00 (approximately \$17.00). For foreign nationals, this fee included in your airline ticket purchase price. No one is exempt from paying the Airport Terminal Fee.

#### Safety

As with all travel, you should be aware of your surroundings at all times and take safety precautions as necessary. Use the same common sense as you would be traveling anywhere. Be cautious in (or avoid) areas where you may be more easily victimized. Avoid wearing flashy jewelry, expensive clothing or display large amounts of cash. Keep valuables in your Hotel Safe. Keep an eye on your wallet especially in crowded areas or markets when you might keep it closer to your body. Don't use black market money changers (the Hotel Concierge can assist you with exchange). Respect the local culture.

Makati City where the conference will be held is the country's central business district. It poses minimal risk of crime or danger. The Philippines as a whole is a safe and lovely place to visit, however, there are specific locations in the far South of the country in which the risk of harm to foreigners is heightened and therefore should be avoided. We recommend that if you are traveling pre and/or post conference that you avoid traveling to the area.

#### **Travel Tips**

Dress for the weather. Light clothing is ideal year-round.

Casual clothing is acceptable inside churches and business offices.

Dining establishments and hotels impose no dress code.

#### **Suggested Conference Dress:**

In September, Manila weather is tropical, hot and humid with periods of rain. Lightweight breathable fabric is recommended. Waterproof outerwear and umbrellas may be useful at times. Suggested Dress for events:

Business: Suit, tie - All Delegate Business Meetings; Closing Dinner

**Casual:** Lightweight Cotton, Khaki or other mid-weight clothing recommended. Long or light denim pants (jeans) or longer shorts (walking) or skirts, collarless shirts or T-shirts. - Optional Tours, Sunday PRAC Delegation Tour.

**Smart or Business** Casual: Long or short-sleeved collared shirts, khaki or dress pant or skirt, no tie. Jacket optional - Saturday Welcome Reception, Saturday Dine-Arounds, Partner Dinners

Cocktail, National Dress (indicative of your country national dress, or business suit, tie - Closing Dinner

#### **TOUR AND INFORMATION GUIDE**

The standard tipping amount is 10% of the total bill. Tipping is optional on bills that include a service charge.

When shopping in a public market, it is perfectly acceptable to bargain for the cheapest price.

Adapt to local customs; accept local differences. The Filipinos are divided into regions, each with its own distinct and traditions.

Be sure to sample the endless variety of native delicacies and local cuisine, which differ in every region.

**PRAC Congregation Group Tour and Luncheon** 

**Time:** 10:00 am – 3:00 pm



Join the PRAC Congregation Group Tour as we discover Manila, the Philippines' capital city and premier gateway to the country. The drive passes through part of EDSA towards reclaimed land by the famous Manila Bay. The group will take a rolling tour of the Cultural Center of the Philippines Complex, which houses some of the landmark structures built during the Marcos dictatorship. These include the Philippine International Convention Center and Folk Arts Theater, which are favorite venues for both local and international events, concerts and performances. Adjacent to the structures are the Coconut Palace, a building made mostly of coconut materials.

The group stops by historic Rizal Park, where the remains of the country's national hero, Dr. Jose Rizal, lie within the Rizal Monument, then continue to the old walled city of Intramuros, which was built during the Spanish colonial period.

Take a step back in time as you discover the charms of Old Manila. The first stop is the Baluarte de San Diego, the only battery directly facing the sea. Take a tour inside the Casa Manila, a reconstructed 19th century mansion replete with 16th to 19th century furniture and furnishings. Then, walk across the street to San Agustin Church, the oldest structure in the Philippines, which dates back to 1571. Luncheon will be at **Ilustrado**, one of Manila's best restaurants.

On the way back to the hotel, delegates and guests have the option of stopping by the Balikbayan Handicraft Store, which carries an amazing variety and assortment of handicrafts—from hand-carved wooden statues, furnishings, and picture frames to tiny shell keychains and knick-knacks. Products are made from wood, shell, fiber, paper, bamboo, vines, resin, leaves, metal, clay and other indigenous materials

**Suggested Dress** As there are several stops, this tour will involve getting on and off the coach several times. Comfortable, non-slip shoes are recommended. Light casual clothes (e.g. walking shorts, cotton t-shirts), light or casual shoes or rubber, hat and sunglasses will be most helpful and comfortable during this tour.

#### **Tour Description**

Colorful jeepneys snake through Metro Manila's major roads and by-ways, making them an essential part of contemporary Philippine Culture. These flamboyantly painted public transportation vehicles are progenies of US Army-issued surplus jeeps from the World War II, which were reconstructed by ingenious Filipinos into passenger vehicles. Enjoy an extraordinary experience that is uniquely Filipino by riding an air-conditioned jeepney whilst taking in the sights of Manila.

Your tour begins with a rolling tour of Makati, the financial and commercial center of Manila, passing through the plush residential village of Forbes Park, dubbed Millionaire's Row, on the way to Bonifacio Gobal City. The tour stops at the Manila American Cemetery & Memorial, the largest and perhaps most beautiful memorial outside the continental United States.

The tour then proceeds to Market! Market! for an introduction to Philippine food through fresh native produce and ends in a family-style lunch at Abe's in Serendra.

#### **Tour Description**

This guided tour takes you to the heart of Manila: Quiapo Church, where Filipino faith and superstition mingle daily; La Loma, the lechon (roasted pig on a spit) capital of the country; and the Manila Chinese Cemetery, the second oldest cemetery in Manila known for ostentatious tombs.

Quiapo Church, or officially known as Minor Basilica of the Black Nazarene, is a Roman Catholic church located in the District of Quiapo, Manila, in the Philippines. It is home to the Black Nazarene, a much venerated statue of Jesus Christ which many people believe has miraculous attributes. The church was painted cream after the original Mexican Baroque edifice was burned down in 1928. Just outside the church, witness tarot readers, walk through a wet market, and light Quiapo's famous colored candles. <a href="http://www.quiapochurch.com/">http://www.quiapochurch.com/</a>

La Loma features block after block of lechon roasters and sellers. Some of the roasting is done at street side pits open to observation. Depending on the size, the pigs are roasted over indirect heat for an average of three hours. The finished lechon are displayed outside the shops. Most are sold whole to party-givers and goers.

The Manila Chinese Cemetery was designated as the resting place for the Chinese citizens who were denied burial in Catholic cemeteries during the Spanish colonial period. A town for the dead that comes with streets and ostentatious tombs built in the form of houses, many of them with furniture, running water and even air conditioning.

Drive to the old Spanish city, Intramuros, for buffet lunch at Barbara's. From Barbara's, drive past Manila Hotel, once the most exclusive address in the Pacific, and was General MacArthur's headquarters during World War II.
